### I. Scale Description

The Supervision Questionnaire – Child (Grade 4+) is an 18-item measure developed for this project to assess facets of parenting supervision and involvement. The questionnaire is based on the Supervision/Involvement Scale of the Pittsburgh Youth Study (Loeber, Farrington, Stouthamer-Loeber, and Van Kammen, 1998), which is related to family factors associated with delinquency (Loeber and Stouthamer-Loeber, 1986) and is based on the Moos' Family Environment Scale (Moos and Moos, 1975) and the Skinner, Steinhauer, and Santa Barbara's (1983) Family Assessment Measure. The questions in this measure generally assess the child's perception of the primary caregiver's knowledge of his/her whereabouts, the amount of discussion and planning regarding communication of his/her whereabouts, the amount of time that the child is unsupervised, and the caregiver's knowledge of the youth's friends. The majority of the questions (12 questions) require the child to respond on a 1 to 5 scale, with 1 meaning almost never and 5 meaning almost always. Two questions ask for curfew times. Three questions about the child's whereabouts require the child to select among six options, with 1 representing home (supervised) and 6 representing other, and one question asks for the number of the child's friends that the caregiver knows.

### II. <u>Report Sample</u>

These analyses were conducted with the first cohort on the control sample (n=155) and on the normative sample (n=387, N = 463 with overlap) during the eleventh year of the study. Overall, 122 records were missing the whole measure. Forty seven were missing from the control sample (10 from Durham, 12

from Nashville, 14 from Pennsylvania, and 11 from Washington) and 105 were missing from the normative sample (20 from Durham, 28 from Nashville, 31 from Pennsylvania, and 26 from Washington).

### III. Scaling

### Subscales

Twelve items in this measure (items 1, 2, 3, 4, 6, 8, 9, 10, 11, 12, 13, and 17) were used in the subscaling for this measure. The remaining six items were not used in the subscaling either because the response required the specific indication of the curfew time for school or weekend nights (items 5 and 7, respectively) or because the responses were coded as categorical (items 14, 15, 16, and 18). All items in these scales are coded on a five-point scale, where 1 represents "Almost Never" and 5 represents "Almost Always."

Three scales were created for these data. The Discussing Daily Activities scale measures the caregiver's interaction with child about the child's daily activities. It consists of items 1, 2, and 3. The Curfew Time scale measures the school and weekend curfews set by the child's caregiver and consists of items 4 and 6. The third scale, the Supervision/Involvement scales measures the caregiver's awareness of and involvement in the child's whereabouts. It consists of seven items: items 8, 9, 10, 11, 12, 13, and 17. The scales were constructed by taking the mean responses to the items in each scale.

### IV. Differences Between Groups

T-tests were used to examine group differences for the total sample (i.e., high-risk control versus normative youth). Analysis of the full sample revealed no significant differences between normative youth and their high-risk control counterparts across scales.

A t-test was also used to examine group differences for item 18 (How many of your friends does your [caregiver] know?). Analysis revealed no significant differences between the normative youth and their high-risk control counterparts for this item.

Chi square tests were performed on item 14 (Where do you usually go right after school?), item 15 (Where do you usually stay in the evening?), and item 16 (Where do you usually stay on the weekends?). There were six possible responses: 1 = home - supervised, 2 = home - unsupervised, 3 = somewhere else - supervised, 4 = somewhere else - unsupervised, 5 = somewhere else - don't know if supervised, and 6 = other.

With  $\chi^2$  (5, N = 341) = 4.7096, p < 0.4523, the hypothesis of independence between risk category (normative or control) and item 14 was not rejected for these data.

With  $\chi^2$  (5, N = 341) = 3.4490, p < 0.6311, the hypothesis of independence between risk category (normative or control) and item 15 was not rejected for these data.

With  $\chi^2$  (5, N = 341) = 3.8066, p < 0.5776, the hypothesis of independence between risk category (normative or control) and item 16 was not rejected for these data.

### V. Recommendations for Use

Analysts should be aware that the instructions given to the children for answering items 5 and 7 (the curfew time for school nights and weekend nights, respectively) were to enter the time as four digits. They then were asked to enter an "a" for A.M. or a "p" for P.M. Their responses were recorded in the data set as variables C1105a (the school night time), C1105b (A.M. or P.M.), C1107a (the weekend night time), and C1107b (A.M. or P.M.). To analyze these times for this report, two new variables were created: schnight (representing school night curfew) and wkdnight (representing weekend night curfew). These variables were created by converting the times entered by the respondents to military time.

Analysts should also be aware that the children appeared to have difficulty determining A.M. and P.M. for the weekend night curfew, as almost 16 percent of the respondents listed 12:00 P.M. (i.e., noon) as their weekend night curfew. In fact, almost 25 percent of respondents listed weekend night curfew times between noon and six P.M. Use of even the created variables schnight and wkdnight may lead to erroneous conclusions.

In addition, analysts should note that all three scales for this measure, the Discussing Daily Activities Scale (SCH11day), the Curfew Time Scale (SCH11cfw), and the Supervision/Involvement Scale (SCH11sup), were normally distributed for both the normative and high-risk control samples.

Finally, analysts should note that analyses of these data show the failure of any of the items or scales to distinguish between the normative group and the high-risk control group.
