### I. Scale Description

The Teacher Rating of Student Adjustment is a 7-item instrument developed by the Fast Track Project to assess dimensions of success in adjusting to middle and high school. The Teacher Rating of Student Adjustment Addendum is a 5-item instrument developed by the Fast Track Project to further assess student's suspensions. Responses are coded as open numeric frequencies.

### II. <u>Report Sample</u>

These analyses were conducted on the data collected on the first cohort of the high-risk Control sample (n=155) and the Normative sample (n=308, N=463 with overlap) from the twelfth year of the study. Of these, 204 students were missing the complete measure. Eighty-eight of the Control students (17 from Durham, 31 from Nashville, 20 from Pennsylvania, and 20 from Washington) were missing the complete measure and 116 from the Normative sample (28 from Durham, 36 from Nashville, 23 from Pennsylvania, and 29 from Washington) were missing the complete measure. None of the missing data was used in the analyses.

## III. Frequencies and Descriptive Statistics

The user should note that missing values are represented by a period (.), 'D' stands for "don't know".

The researcher must keep in mind that these variables are not directly comparable to the aggregate scores described in the technical reports for years 7 through 9. The addendum only measures suspensions and disciplinary actions taken by the school. Comparisons over time would involve a single teacher's rating for each student. These scores would be comparable to the single teacher ratings contained in years 10-12.
